- Takes concentrated positions in high-quality businesses that are undervalued and undermanaged but offer multiple avenues toward value creation. Approach centers on unlocking catalysts through engaged shareholder activism/intervention. SMIDs focus offers a broader universe of attractive investment targets where deep fundamental DD can lead to price discovery given less market efficiency and the potential for meaningful value dislocation compared to a company's intrinsic value.

- Uncorrelated FX focused global macro / absolute return fund with daily liquidity

Jason Lewis, Greenlight Capital, New York, NY

- A value-oriented investment management firm founded in May 1996 that primarily invests and trades in long and short publicly listed equity securities, as well as distressed debt when cyclically attractive.

- A Critical Industries SBIC Fund. BBK Capital was chosen as the 1st fund by The U.S. DoD's Office of Strategic Capital (OSC) and the SBA to invest in American fund managers and companies operating in critical industries and technology sectors. In this new program, for every \$1 dollar BBK raises, the OSC and SBA matches/contributes \$2 dollars. This creates an incredible capital structure that yields 400 - 1000 basis points of spread on all returns.

Lane Murphy, Mast Hill Fund, Boston, MA

- Private Credit, Short Duration (1 year), Convertible Note Fund lending exclusively to public companies in the Small & Micro Cap space - NYSE and NASDAQ only - no bulletin board or OTC companies.

Casey Gard, GFO Asset Management LLC, Miami Beach, FL

- Capital appreciation through a diversified portfolio of litigation finance investments.

Vadim Margulis, Alignment Credit Fund III, New York, NY
